As per Section 24(1) the Committee shall meet at least four times in a year.
2.	Academic Council	As per Section 26 (1) of the Maharashtra State Skill Universities Act, 2021.	As per Section 26 (1), The Academic Council shall be the principal academic authority of the University and shall be responsible for regulating and maintaining the standards of skill education and employability training, research and evaluation in the University. It shall also be responsible for laying down the academic policies in regards to maintenance and improvement of skill education and employability training, research, extension and collaboration programmes.	As per Section 26 (1), the Academic Council shall meet not less than four times in a year.

11.	Fee Fixation Committee	As per Section 57 (1) (i) of the Maharashtra State Skill Universities Act, 2021.	As per section 57 (1) (i), There shall be a Fee Fixation Committee to work out the real cost of delivery of each and every under-graduate and post-graduate courses or programmes run by the university, colleges and recognized institutions, other than autonomous colleges and autonomousinstitutions and those managed and maintained by the State Government, Central Government and local authorities.
